# INTELLECTUAL PROPERTY COMMERCIALISATION ANALYST

## PERMANENT, FULL-TIME

**JOB OVERVIEW:** Do you want to get your foot in the door to the world of commercialisation? This is a great opportunity to expand your experience in the commercialisation of research and technology development and would be a valuable career step for anyone interested in a future in commercialisation.

### THE ROLE

As an Analyst you will work with the Intellectual Property Commercialisation team assessing technologies developed by Victoria University's world-class academics. This involves using our suite of industry-standard market intelligence & IP tools to identify and assess invention disclosures and support Wellington UniVentures' Intellectual Property Commercialisation process and Intellectual Property pipeline management across a broad range of subject areas.

The core of your role is your involvement in the invention disclosure process -assessing new disclosures by meeting with research groups, engagement within the industry (market research), desk research, managing associated information and assisting the team to generate new invention disclosures.

You will assist with the development of project plans and budgets, market opportunity assessments and validations and technology development planning. Helping our commercialisation managers deliver project objectives you will support written applications for funding, support the gathering of information, reporting and provision of analysis during partner qualification and negotiations.

Assisting the team with initiatives to enhance entrepreneurial culture with University academics and students will enable great relationships and help to generate new invention disclosures.

### YOUR EXPERIENCE

We're after someone with a scientific mind, who can wrap their head around new (and sometimes complicated) scientific and technological concepts quickly. An affinity with or an understanding of business would be an advantage. A post-graduate degree is also important. Critical thinking and problem solving skills are crucial. You will have exceptional commercial skills or be motivated to improve them.

You need to be able to communicate science and relevant commercial information clearly and succinctly both orally and in written form. Knowledge of tikanga Māori, Pasifika perspectives, and an understanding of the Treaty of Waitangi are important.
